

**Abdulrahman Sulaiman Mohammed Al-Salmi (Oman)**

holds a PhD degree from Durham University, UK (2001). Editor-in-Chief of *Al Tasamoh* (Tolerance) journal, published by the Ministry of Endowments and Religious Affairs of the Sultanate of Oman. He is a Professor of Islamic Studies at the Institute of Shariah Studies, in Muscat, Oman, and is in charge of organizing the early international conference hosted in Oman on Islamic Jurisprudence. He has been author and editor of dozens of books and articles in newspapers, magazines, periodicals and encyclopedias.

**Candido Mendes (Brazil).** President of Candido Mendes University, President of the Rio de Janeiro Forum of Rectors, member of the Brazilian Academy of Letters, Secretary-General of the Academy of Latinity, member of the Economic and Social Development Council to the Presidency of Brazil, President of the Senior Board of the International Social Science Council (ISSC) and Alliance of Civilizations Ambassador. He was also Secretary-General of the Brazilian Justice

and Peace Commission and President of the International Political Science Association (IPSA). Among his most recent books are *A Presidência Afortunada* (1999), *Lula: a Opção mais que o Voto* (2002), *Lula depois de Lula* (2005), *Lula apesar de Lula* (2006), *Dr. Alceu, da 'Persona' à Pessoa* (2009), and *Subcultura e Mudança: por que me Envergonho do meu País* (2010).

**Cristovam Buarque (Brazil).** Holding a PhD degree in Economics from Sorbonne, he has worked at the Inter-American Bank of Development, has been Rector of the University of Brasília, Governor of Brasília, and Minister of Education. He is currently Senator at the Brazilian National Congress, Professor at the University of Brasília, ex-member of the Unesco Education Institute and a member of the Council of the United Nations University. He is the author of several books, translated and published in English such as: *The End of Economics?* (1993), *Abolishing Poverty* (2005) et *The Gold Curtain* (2007).

**Daniel Innerarity (Spain).** Full Professor of Political and Social Philosophy, IKERBASQUE Researcher at the University of the Basque Country, and Director of its Institute for Democratic Governance ([www.globernance.com](http://www.globernance.com)). He has been Visiting Professor in several European universities, including the Sorbonne, where he taught recently. PhD in Philosophy, he developed further studies in Germany (with a scholarship of the

Alexander von Humboldt Foundation), Switzerland, and Italy. Among his most recent books, one should mention: *Ética de la hospitalidad* (2001), *La transformación de la política* (III Miguel de Unamuno Prize for Essays and National Prize of Literature, modality essay, 2003), *La sociedad invisible* (Espasa Prize for Essays, 2004), *El nuevo espacio público* (2006), *El futuro y sus enemigos* (2009), *La democracia del conocimiento* (2011), and *La humanidad amenazada: gobernar los riesgos globales* (with Javier Solana, 2011). Most of his books have been translated into French, English, Italian, and Portuguese.

**Dirk Vandewalle (USA)** is Associate Professor of Government at Dartmouth College. He holds a Masters degree in International Affairs and a PhD in Political Science from Columbia University. He is the author of *A History of Modern Libya* (2006), “Social Contracts, Institutional Development and Economic Growth and Reform in Middle East Oil Exporters,” background paper for Tarik Yousef, *The Employment Challenge in the 21st Century: From Labor Force Growth to Job Creation*, a regional economic report on the Middle East and North Africa, written for the World Bank, 2004; *Libya Since Independence: Oil and State-Building* (1998).

**Dominic Boyer (USA)** teaches Anthropology and Social Theory at Rice University with a special focus on the intersection of media and knowledge. His forthcoming book, *The Life Informatic*, explores the transformation

of news journalism in the era of digital information and communication technology. With Alexei Yurchak, he is writing on the appearance and mobilization of late socialist aesthetics of parody in contemporary western political cultures. With Cymene Howe, he is researching the politics of energy transition and how energopolitics constitutes an alternative genealogy of modern power to biopolitics.

**Fernando Coronil (Venezuela).** Holding a PhD degree from the University of Chicago, he is Presidential Professor of Anthropology at the Graduate Center of the City University of New York and Emeritus Professor of the Departments of Anthropology and History at the University of Michigan. He is the author of numerous works on postcolonial theory, capitalism, and Latin America, including a co-edited book, *States of Violence* (2005), and published in 2011 *Anthrohistory: Unsettling Knowledge, Questioning Discipline*. His major work is *The Magical State: Nature, Money and Modernity in Venezuela* (1997).

**François L'Yvonnet (France).** Professor of Philosophy and Publisher in Paris. His more recently published works include: "*Michel Serrès*", *Cahier de l'Herne* (2010), *Louis Massignon, Écrits mémorables* (with Ch. Jambert, Fr. Angelier and S. Ayadá, 2009), *Le Défi de la différence* (with Candido Mendes, 2006), *Simone Weil, le Grand passage* (2006), and "*Baudrillard*", *Cahier de l'Herne* (2005).

**Gerardo Caetano (Uruguay).** Historian and political scientist. PhD in History. Coordinator of the Observatório Político, Institute of Political Science of the Universidad de la República, Uruguay. Academic Director of the Centro de Formación para la Integración Regional (CEFIR). Member of the Superior Board of the Latin American School for the Social Sciences (FLACSO). Member of the Board of Directors of Latin American Council for the Social Sciences (CLACSO). Academic Secretary of the Uruguayan Center for International Relations (CURI). Author of numerous publications in his field of research.

**Javier Sanjinés C. (Bolivia)** is Professor of Spanish at the Department of Romance Languages and Literatures, University of Michigan, Ann Arbor. He has published extensively on Bolivian literature and culture. His books include: *Estética y carnaval. Ensayos de sociología de la cultura* (1985), *Literatura contemporánea y grotesco social en Bolivia* (1992), *Mestizaje Upside Down: Aesthetic Politics in Contemporary Bolivia* (2004), and *Rescaldos del pasado: conflictos culturales en sociedades poscoloniales* (2004).

**Juan Cole (USA)** is the Richard P. Mitchell Professor of History at the University of Michigan and the Director of its Center for South Asian Studies. He is author, most recently, of *Engaging the Muslim World* (rev. edn. 2010), *Napoleon's Egypt* (2007), and *Sacred Space and*

*Holy War: The Politics, Culture and History of Shiite Islam* (2002). He maintains a weblog on the politics of the Muslim world, *Informed Comment*.

**Luis Martinez (France)** holds a PhD degree in political science from the Institut d'Etudes Politiques de Paris (1996). He was Visiting Professor at Columbia University, New York (2000-2001) and at the University of Montréal (2007-2008). A political scientist and a specialist of the Maghreb and the Middle East, he is currently Research Director at the Centre for International Studies and Research (CERI/SciencesPo) in Paris. His research contributes to the CERI Transversal Project "The End of Violence". Among his most recent books are *The Enigma of Islamist Violence* (2007), *The Libyan Paradox* (2007), and *Violence de la Rente Pétrolière, Algérie-Irak-Lybie* (2010).

**Mário Lúcio Sousa (Cape Vert)**. Bachelor of Laws by the University of Havana, Cuba, he has been a Representative at the Cape-Verdean Parliament between 1996 and 2001. He has acted as a Cultural Ambassador of Cape Vert and is presently its Minister of Culture. He is also a musician and writer, being the author of the following works: *Nascimento de um Mundo* (poetry, 1990); *Sob os Signos da Luz* (poetry, 1992); *Para nunca mais Falarmos de Amor* (poetry, 1999); *Os Trinta Dias do Homem mais Pobre do Mundo* (fiction, 2000); *Vidas Paralelas* (fiction, 2003); *Saloon* (drama, 2004); *O Novíssimo Testamento* (novel, 2010).

**Michel Wieviorka (France).** Professor and Director of Studies at the École de Hautes Études en Sciences Sociales, and President of the Fondation Maison des Sciences de l'Homme in Paris. Being a Sociologist, he was also the President of the International Sociology Association (ISA, 2006-2010). His works concern different figures and forms of the good (social movements, democracy, political treatment of cultural or religious differences, etc.) and of the evil (racism, terrorism, violence, etc.). His most recent works are: *Neuf leçons de sociologie* (2008, forthcoming translations into English and Spanish), and *Pour la prochaine gauche* (2011).

**Renato Janine Ribeiro (Brazil).** Professor of Ethics and Political Philosophy at the University of Sao Paulo. He has been Director of Evaluation at Capes, the Brazilian agency for the evaluation of graduate education, and Tinker Professor at the University of Columbia, in New York. He wrote several books in Political Philosophy, two of them on Thomas Hobbes, and other works on the problems arising when one tries to build a democracy in a dissident Western society, as Brazil. He won the 2000 Jabuti award for the best essay published in Brazil in that year, with his *A Sociedade contra o Social – O Alto Custo da Vida Pública no Brasil*, his first essay dealing with the subject.

**Renato Lessa (Brazil)** holds a PhD in Political Science from the University Research Institute of Rio de Janeiro (IUPERJ)/Candido Mendes University. He is currently

Professor of Political Theory at Universidade Federal Fluminense (UFF) and Researcher of the National Council for Scientific and Technological Development (CNPq). He was Visiting Professor at the École des Hautes Études en Sciences Sociales in Paris, and Executive Secretary and Committee member of the Brazilian Association of Political Science (ABCP). He is the author of *Agonia, Aposta e Ceticismo: Ensaios de Filosofia Política* (2003), *A Invenção Republicana: Campos Sales, as Bases e a Decadência da Primeira República Brasileira* (1999), and *Veneno Pirrônico: Ensaios Sobre o Ceticismo* (1997).

**Susan Buck-Morss (USA)** is Professor of Political Theory at the City University of New York Graduate Center and Cornell University. Recent books include *Hegel, Haiti, and Universal History* (2009), *Thinking Past Terror: Islamism and Critical Theory on the Left* (2003), and *Dream World and Catastrophe: The Passing of Mass Utopia in East and West* (2000).
